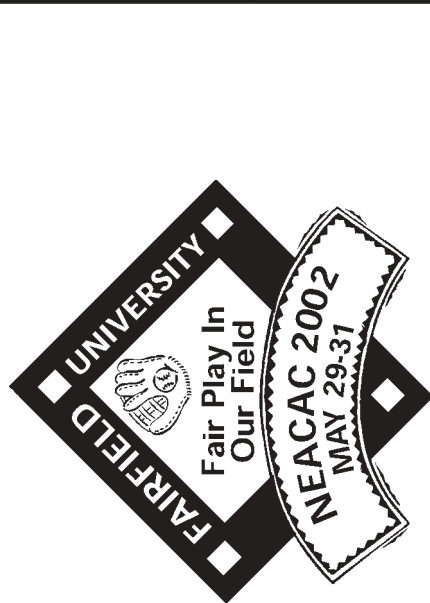

REMEMBERING HARRY

In a recent meeting of the NEACAC committee charged with the responsibility for selecting the Harry Carroll Award recipient, I was surprised to learn that I was the only person in the room who had known Harry personally and one of only a handful who knew who Harry was. Since the award which bears Harry's name is still considered by most of our members as our association's highest honor, I thought it might be appropriate for someone like me to share some reflections on the early years of our association and some of the characters who led our profession in New England over the first decade as we look ahead to another presentation of the Harry Carroll Award in our fourth decade as an association.

After two years as an admissions officer at Bard College, I was hired as the first Director of College Counseling at Worcester Academy in the summer of 1970 and joined NEACAC that fall. While working in admissions at Bard, I had attended my first NACAC Annual Conference in New York City in 1968. At that conference, through a friend of my Director, I met Harry Carroll, who was the Director of Admissions at Colby College, a position he had held for several years after many years as Director of Admissions at University of New Hampshire. Harry and I had actually talked on the telephone the year before, when I was teaching at Phillips Exeter, about one of my advisees who had applied to Colby. When we met in New York, Harry recalled our telephone conversation, remembered the student, and told me how the boy was doing at Colby during his first few weeks there. I remember thinking to myself at the time how impressed I was with this man who knew my advisee and how that young man was doing only a few weeks into the year, and who then conversed so easily with me about my new career in college admissions, encouraging me to stay in the "business" for the long haul. I was fortunate to start my career with several role models like Harry, whose principles

were exemplary and who always kept the *students* at the center of their professional attention and influenced me to do the same.

Since Colby College was a popular destination for Worcester Academy students, I soon developed more than just a passing acquaintance with Harry Carroll and with many other "old guard" directors. (Of course, there will always be an "old guard," but those who qualify keep changing, and you never expect to be considered for the label.) By the end of my first year in college counseling, I was an active member of NEACAC, which was then entering its *fifth* year as an association. That year, Jim Climo, Director of Guidance at Longmeadow High School, was the President, and Harry Carroll was President-Elect.

The early years of the association were remarkably different than the past couple of decades. There were no computers, no email, no cell phones, and no college rating lists. There was, in fact, no profession as we now know it, since the college admission process was just developing into a separate entity within the world of education and was creating its own jargon as part of the development. The Candidates Reply Date (May 1st) had just been determined and agreed to by colleges and schools across the country. The terms which we now use were beginning to appear: Regular vs. "Rolling" Admission was a new concept; Early Decision was a contractual agreement in place at only a small number of highly selective colleges, and there was no Early Action or "second round" of ED. ACT was a new player in the testing game. SAT and Achievement Tests (not SAT II) were given on the same day in AM and PM sessions, and somehow students survived.

NEACAC, under the leadership of some truly extraordinary men and women, played a major role in shaping the profession as it is today. NEACAC was the largest of the State and Regional Associations affiliated with NACAC (then called the National Association of Col-

lege Admissions Counselors, not for College Admission Counseling), and we were the guiding light at the national level. From NEACAC came not only the ideas but often the leadership and the people themselves who developed the policies which governed the profession which was emerging around the previously simple process of students progressing from secondary school to college.

In the early 1970's, NEACAC wrestled with many controversial issues the results of which have had profound ramifications for the entire process. In 1974, the Buckley Amendment as part of the Family Educational Right to Privacy Act (FERPA) was passed in Washington, and the process as we had known it was changed forever. Legal issues began to arise within the college admissions process, and we were thrown into an arena where few of us had ever played. NEACAC had to abandon its organizational structure, discard the constitution which governed the association, incorporate ourselves into a legal entity, and draft new Articles of Incorporation and By-Laws. Harry Carroll served as the chairman of the committee that wrote most of these documents. I served with Harry on that committee and succeeded him as chair when Harry died unexpectedly in 1981.

During this same decade, the concepts which had been considered foreign to "our" process, marketing, institutional image building, and consumerism, began appearing in our conversations, and many felt the need to formalize the simplistic Code of Ethics which had been the backbone of NACAC since its foundation in 1937. With Dr. Margaret Addis playing a key role at both the national and regional levels, the Statement of Principles of Good Practice was conceived and written. Margaret Addis was the driving force behind SPGP in both organizations, NACAC and NEACAC. Subsequently, statements of Students' Rights and Responsibilities and Transfer Stu-

dents' Rights and Responsibilities came into existence largely under the direction of Gail Roycroft, another NEACAC leader, who retired last year from Marshfield High School.

One of the other major challenges confronting the emerging profession during the 70's was the drive to provide greater access to higher education for minorities and underserved segments of the general population, prompted largely by the successes of the Civil Rights Movement of the previous decade. Again, NEACAC took the lead and worked closely with the newly founded organization NECBAC to establish programs and services specifically targeted at increasing opportunities for access to higher education for all student populations.

Throughout these years, NEACAC was the only professional association that routinely brought college admission officers and school guidance counselors together to address the myriad of concerns both sides of the desk faced and which could only be effectively addressed through working together. For example, when the late 1970's saw high school college nights proliferate to the point at which NEACAC actually created a position on the Governing Board for a

Coordinator of College Nights in an attempt to make it possible for college admissions offices to assign staff more effectively, the NEACAC Governing Board proposed creating regional college fairs with the hope that individual high school college events would become unnecessary. The first of those fairs was held at St. Anselm's (now St. Anselm) College and was chaired by Don Healy, who was "volunteered" for the job by his old friend, Gene Savage, down the road at UNH.

NEACAC had started to stage College Fairs throughout the country just before NEACAC began our own fairs, but the national fairs were expensive for colleges because they used commercial venues with attendant high costs. The NEACAC Fairs were, and still are, held on college campuses, with the host college often helping with the general expenses and providing lots of support from its own personnel, and the participating colleges benefited from the lower overhead. Incidentally, when the idea for NEACAC College Fairs was first proposed, I remember distinctly that the Governing Board agreed unanimously that the Fairs should never be a source of revenue for the organization. However, within a few short years, the organization found that the Fairs generated income for the association in spite of the intended altruism, but we need to re-

member that the principle of providing service to students and parents with as little cost as possible to colleges was the force behind the NEACAC Fairs. Through the years, the Fairs have become reliable vehicles for communication among professionals as well as giving countless thousands of students the opportunity to get valuable infor-

mation as they began the admission process. There are not many left in the profession who can recall the college admission process without College Fairs; remembering life without College Fairs used to be one of the qualifications for "old guard" status, but that, too, will eventually change.

Looking now at the lists of those who served on the Governing Board of NEACAC during those first few years, I note many who have passed away and more who have retired. A few have recently retired and are still well known to many who are currently active in the profession. An increasingly smaller number of us who have joined the "old guard" are still active in our careers and in the work of the association.

If you read down the list of those who hold Honorary Membership and/or who have received the Distinguished Service Award, which was renamed the Harry Carroll Award in 1982 to preserve the memory of one of the association's early leaders, you will discover the names of those who took time from their professional positions in schools and colleges to devote countless hours to this association. In many cases, these men and women actually created and designed elements of the profession of college admission counseling. If you were to ask any one of them today what the profession which they helped to shape was all about, there would be a unanimous answer: *helping students and their families through the challenging transition from school to college.*

When the Harry Carroll Award is presented at the Annual Meeting, it not only pays tribute to someone who has made an outstanding contribution to the profession, but it preserves the heritage of the ideals of those who actually *created* the profession in which we now work.
